

- This product meets all international standards of animal identification (ISO 11784/ISO 11785). Each syringe is produced using top quality European chips with read/write capability and features unique data security. Coupled with Fofia Tech reader series, ZS006 provides a beneficial solution in animal breeding, slaughter management and animal identification.

- This syringe is light, handy and cost saving comparing with other similar models

HomeSafeID (HSID) unique microchips have a proven record for quality and reliability for use in the electronic identification of companion animals, horses, birds, small animals and wildlife.

HSID microchips are manufactured under the strictest quality control of ISO 9000. All components used in the HSID microchip must be inspected under the AQL 0.65%. Syringe parts must be inspected to a level of 100% viability before releasing to the production line.

Upon delivery, every single HSID microchip is traceable back to the organisation which it was sold prior to registration taking place.
